#### **Call for Papers**

On October 27, 2024, the forum "Disinformation, Journalism and Civil Society" will take place at the Main Auditorium of the Porto Accounting and Business Administration (ISCAP). This event is organized by the Polytechnic Institute of Porto, in collaboration with research groups INDESO (Legal Regulation and Digital Citizen Participation) and COMEIN (Communication, Methodologies, and Innovation, UCM). The event will begin at 10:00 AM and will feature specialists from various fields.

These sessions are funded by NATO through the "NATO Public Policy Fellowships" project and aim to promote reflection and dialogue on the impact and prevention of disinformation in society, with particular emphasis on the role of journalism and civil society in protecting informational integrity.

In a context where disinformation continues to challenge the integrity of information and public trust in institutions, journalism and civil society emerge as essential pillars in building an informed and resilient society. This event proposes an in-depth analysis of the dynamics linking disinformation, journalism, and civil society engagement, exploring how these interactions affect democracy and social cohesion.

With the proliferation of manipulated content and the rapid spread of disinformation facilitated by social networks and digital platforms, critical questions arise regarding the role and responsibility of journalism as a guardian of truth and civil society as an active agent in defending accurate information. The digital age imposes new challenges for fact-checking, transparency, and journalistic ethics, as well as for empowering civil society to identify and respond to misleading content.

This event seeks to foster dialogue among specialists, journalists, legislators, academics, and civil society representatives on effective strategies to mitigate the impact of disinformation. From the need for balanced regulation of digital platforms to the importance of media literacy and fact-checking initiatives, the conference aims to explore innovative and collaborative approaches to protect the informational ecosystem and strengthen public trust.
